## We hope you have a successful hunt!

After your hunt is over, your trophies will be turned over to a taxidermist/dip and pack company. Once their process is complete, they will then turn your trophies over to a Shipper. The Shipper will then arrange transportation for the trophies to the United States. Once they arrive Trophy Shippers will then clear your trophies through US Customs, Agriculture and Fish and Wildlife then have them delivered directly to your chosen Taxidermist, USDA Approved Establishment or your preferred Delivery Address.

**IMPORTANT:** Please note that whichever delivery address / point you choose, must have adequate equipment and forklift to offload your trophy from our truck.

To expedite this process, you are required to provide all relevant information required on the US Customs Power of Attorney form. We will need this form completed and returned to TROPHY SHIPPERS ASAP with a copy of your driver's license or passport. We will need the POA Form to process clearance, and we request you send these to us by email at least 72 hours prior to your shipment arriving in the US. (The sooner the better.)

We would request that you advise us when you hear from your outfitter about the return of your trophies and at the point copy us in so we may track the process of your shipment. It is important that your outfitter liaises with Trophy Shippers in advance of the shipping of your trophies to the US so we can check and ensure all the required paperwork, permits, etc. have been received.

Once all relevant documents are in place on our end and Trophy Shippers receives the shipping information and pre-alert in advance, we will then be able to make a timely submission to US Agriculture, US Fish and Wildlife, CDC and US Customs to clear your shipment through all government agencies upon arrival.

**IMPORTANT:** To avoid costly airline storage fees caused by delays in the USDA's release of trophy shipments, Trophy Shippers must receive all required paperwork before your trophies arrive in the U.S. These storage fees apply while your shipment is held at the airport or port awaiting USDA release. Trophy Shippers does not add any profit to these charges. We prepay the fees to the airline and bill them back to the client at the exact cost.

Once cleared, TROPHY SHIPPERS will then coordinate the delivery to your taxidermist or chosen delivery address.

The clearance process for trophies on average can take from 3 days to about 2 weeks with proper cooperation from the federal authorities.

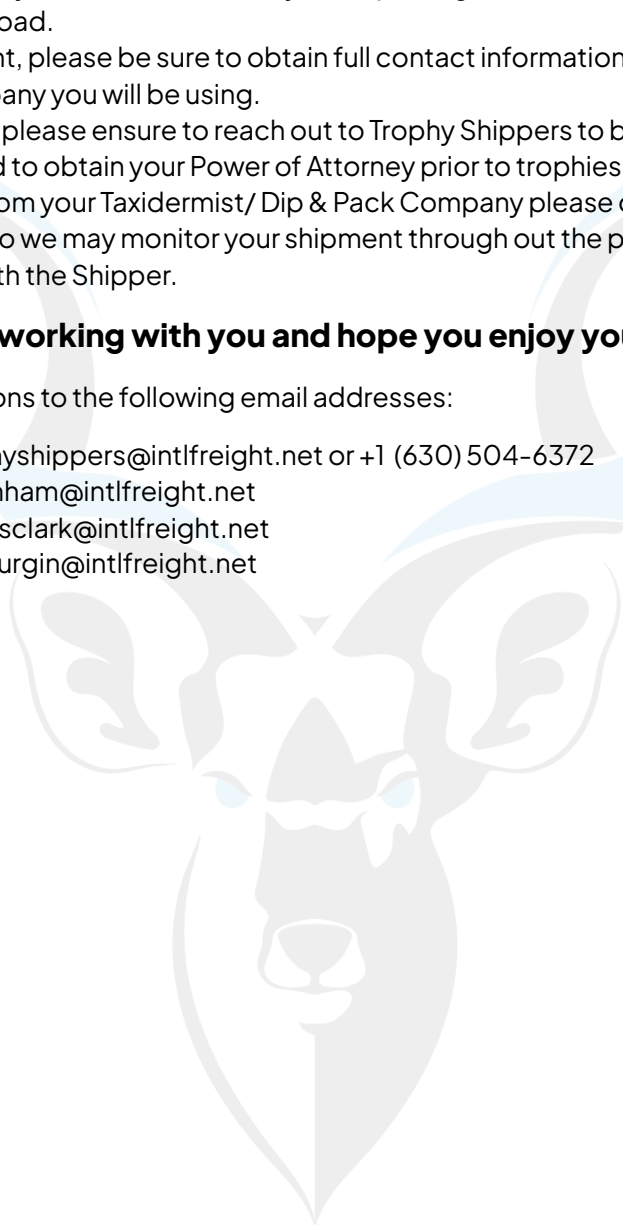
## Know before you go

- Once you return, please ensure to reach out to Trophy Shippers to be on alert of the arrival of your trophies and to obtain your Power of Attorney prior to trophies arriving.
- Once you hear from your Taxidermist/ Dip & Pack Company please copy Trophy Shippers in on your e-mails so we may monitor your shipment through out the process and communicate with the Shipper.
